### FAQs

**1. Does the Sneak Peek mean I get to appeal my NTRP early as well?**

Unfortunately, no. If you complete a Safe Sport course (or are Safe Play Approved through December 31, 2024), you will receive an email on November 29, 2024 containing your NTRP for next season. You will have an opportunity to appeal that rating when it is officially released on December 3, 2024. Appeals can be initiated the same way as in the past through Tennislink.

**2. I'm having trouble accessing the Safe Play training. Who should I contact?**

**3. I'm already Safe Play Approved because of my role with the USTA. Am I able to receive my NTRP early?**

As long as your Safe Play Approval is in place as of November 11, 2024 and is effective through December 31, 2024, then you too will receive the sneak peek to your NTRP.

**4. Which course do I need to complete in order to receive my Sneak Peek?**

While we are encouraging League and Adult Tournament players to complete the course entitled *Abuse Prevention for Adult Athletes*, if you prefer to complete the course for Parents (entitled, *Parents Guide to Misconduct in Sport*) or Volunteers (entitled, *SafeSport for Volunteers*), those will also satisfy the requirement needed to get your Sneak Peek. **5. How long are the courses?**

The courses entitled *Abuse Prevention for Adult Athletes* and *Parents Guide to Misconduct in Sport* both take between 20 - 30 minutes to complete; the course entitled, *SafeSport for Volunteers* takes about 10 minutes to complete. **6. I already completed one of the Safe Sport courses through USTA earlier this year, am I still eligible to receive my Sneak Peek?**

Yes! Anyone who completed a Safe Sport course through the USTA platform between January 1, 2024, and November 11, 2024, will receive a sneak peek of their NTRP rating as a thank you for their commitment to athlete safety. **8. I already completed a Safe Sport course but for a different sport. Can the USTA reciprocate that completion for this incentive?**

Our system can only recognize Safe Sport courses completed through the USTA.com platform. This ensures the completion is linked to your USTA account. We can confirm the SafeSport Core training (required for USTA Safe Play Approval). However, the shorter trainings for adults, parents, and volunteers (found [HERE](#)) must be completed through your USTA account to qualify for the Sneak Peek.
